Bestlan Group of Companies manufacture, develop and trade value added fruit and vegetable products to meet the requirements and specifications of our customers in harmony with our company's policy.

Company Processes

- Frutbite are functional food pieces which can be fruit, vegetable or confectionary based, which
 have been dried
- Frute are extruded pieces which can contain dried fruit or vegetable pieces.
- Frutpic are manufacturing of purees (smooth and chunky), pastes, preparations, sauces, ripples, jelly fillings and RTD juices and/or vegetables, sweet and savoury preparations, and suspended preparations, juice, juice concentrates; blending of juices or juice concentrates; trading of IQF fruit, IQF vegetables, purees, organic purees, pastes.
- Frutmax are a high quality fruit piece with high fibre from the fruit and a low water activity.

Food Safety

It is our obligation to ensure that the products we manufacture or supply are always safe to eat.

Our food products is prepared to the highest standards using quality products and ingredients and as the very minimum we will comply with all relevant legislation and approved codes of practice, as well as best practises and common minimum operating standards.
